AT Computer Solution Ltd (ATCSL) will be responsible for facilitating and conducting CISCO IT Essentials Training and online vendor exam to students of Mymensingh Polytechnic Institute for free of cost. In addition, ATCSL will provide other services such as Trainings on CISCO, RedHat Enterprise Linux, MikroTik, Microsoft, Oracle and online vendor certification exams including registering and scheduling of exam at its Pearson VUE Testing Centre for students of Mymensingh Polytechnic Institute. ATCSL will continuously cooperate in creating Industrial Attachments and or employment opportunities for students of Mymensingh polytechnic institute as ATCSL will help additional skills of Mymensingh polytechnic institute students to industry standard.

#### **Financial Terms**

Except Cisco IT Essentials, students will bear the cost of Training and Exam Fees for any services and any other charges as mutually agreed upon of every student referred by Mymensingh Polytechnic Institute.

#### **Intellectual Property Rights**

Both parties will ensure that all data is protected and not made available to any unauthorized individuals or organisations. All materials relating to the training curriculum, programs of study and their content remain the intellectual property of the holder and may not be assigned, sold or gifted to any third party unless specifically authorized by the holder in writing.



#### **Duration of MoU**

This MoU, unless extended by mutual written consent of both parties, shall expire in five (5) years after the effective date specified in the opening page (page 2). However, on review, the MoU may be extended for another year by mutual consent.

#### **Notices**

All notices required to be served under this agreement shall be in writing and may be served by personal delivery, facsimile or by first class post upon the parties at their addresses set forth in this agreement and such notices shall be deemed to have been served if sent by personal delivery, at the time of delivery, if sent by facsimile, upon entire transmission to the then current facsimile number of the relevant party and receipt thereof and sent by first class post, within two (2) business days after posting.

### **Governing Law & Settlement of Dispute**

This agreement shall be governed by and construed in accordance with the law of the Government of the People's Republic of Bangladesh. All disputes relating to the terms and conditions of this Agreement shall be settled amicably between both the parties within 30 (thirty) days. If the amicable settlement fails or that 30 (thirty) days period expires without any settlement then that dispute shall be referred to arbitration in accordance with the provisions of the Arbitration Act, 2001. Each party shall appoint its -\*+98shlo/ wn arbitrator and the arbitrator parties shall appoint a third arbitrator who shall be the Chairman of the Arbitral Tribunal.
